Title: MC01 – Algorithmic trading of DAX futures

Strategy Objectives & Approach

The fund invests using a computer algorithm, trading DAX futures using mean reversion. The strategy is systematic and only trades one instrument: the DAX future. The model has analysed all c. 14,000 days that the DAX has traded in its history, and now recognises short-term patterns that have occurred in the past, when similar patterns occur in the present.

The strategy employs no leverage. Positions are held for an average of 2 days. Returns are uncorrelated with those of other asset classes (including other systematic strategies) meaning that, by holding this strategy in a portfolio, an investor will reduce overall portfolio volatility. The fund aims for returns of 10% annualised (net of fees) with around 10% annual volatility.

How the Algorithm Works

- Step 1: The algorithm detects an up or down trend
- Step 2: The algorithm takes a view on the shape of the trend
- Step 3: Risk component – leverage is reduced as the volatility of the DAX rises, in a 100% systematic way.

The algorithm is short-term trend following, ensuring a losing position is quickly flattened. There is no set stop loss level.
